Installation of new 48 cavity compression molding line (SACMI) for closures with an installed capacity of 2.9 million closures per day. Time line- Before November 2020

Introduction of new AB series of 29/25 closure with 48 cavity (AB29W21). The design is coke approved and lowest possible weight available in the market produced by compression molding technology.

Introduction of 11.6 g, 72 cavity preform mold suitable to husky machine with 29mm neck finish. Average installed production capacity will be 850K preform per day. Time Line- Before December 2020

## OUR FUTURE PLAN

Introduction of 21.7 g, 72 cavity preform mold suitable to husky machine with 28mm/1881 neck finish. Average installed production capacity will be 500K preform a day. Time Line- Before March 2021

Introduction of 15.5 g, 72 cavity preform mold suitable to IPS (SACMI) machine with 28mm/1881 neck finish. Average installed production capacity will be 590K preform a day. Time Line- Before October 2021

Installation of new six cavity PET stretch blow molding machine with an installed capacity of 150K bottles a day

We have earmarked a total amount of 6million USD on CAPEX for


