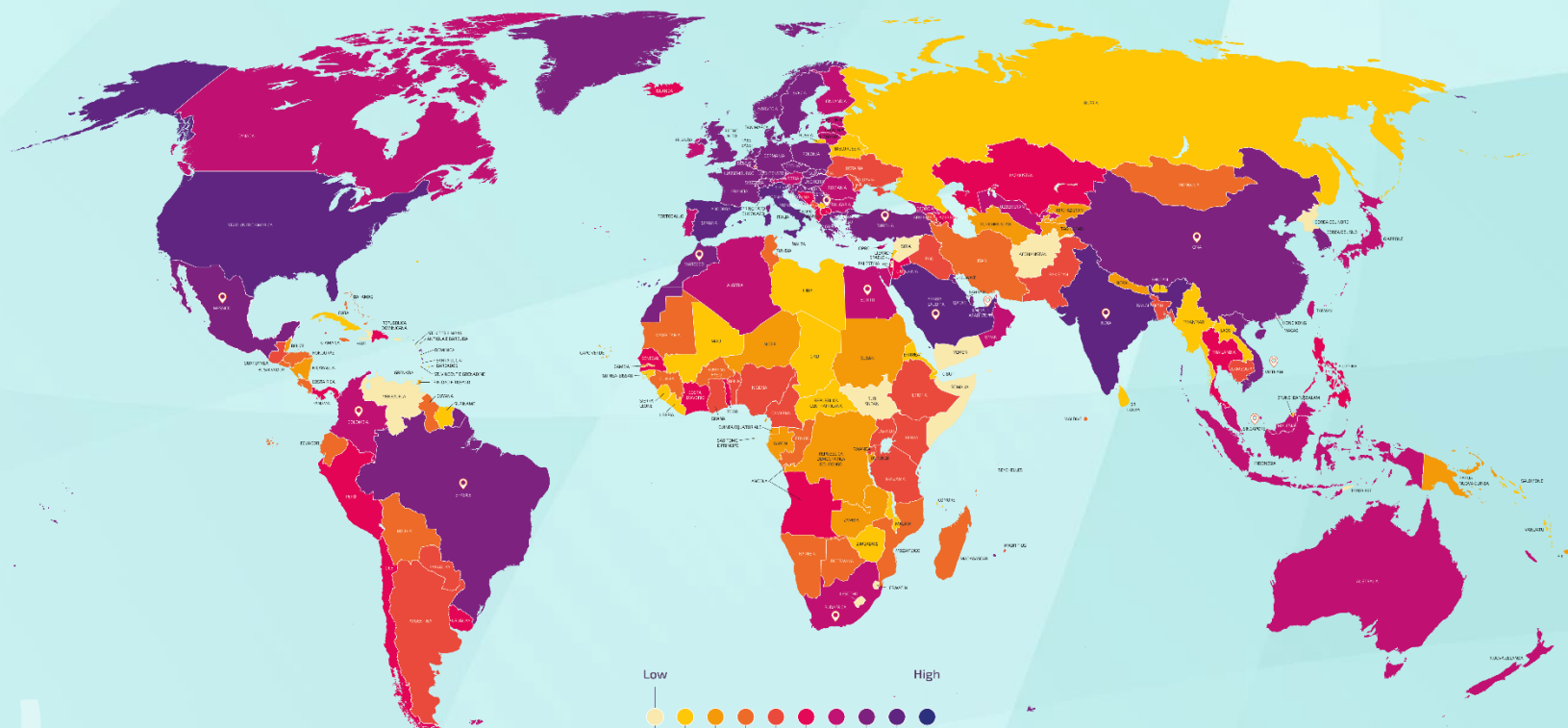
Products and solutions

- **Export credit:** providing insurance cover for enterprises and financial institutions
- **Investment protection:** protecting Italian foreign investments against political risk in geopolitically complex environments
- **Financial guarantees:** facilitating access to credit by guaranteeing bank loans
- **Project & structured finance:** supporting major capital projects in Italy and abroad
- **Sureties, Bid and performance bonds:** supporting participation in international tenders and ensuring proper contract execution, ensuring a more efficient financial management
- **Credit insurance:** insuring companies against the risk of non-payment
- **Construction risk:** protecting capital in order to allow companies to meet their contractual or legal obligations
